

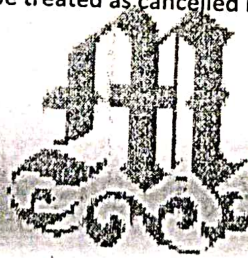



(1) The organisers shall have to provide the required land, as assed by the University Inspecting Team by way of registered deed, free from all encumbrances, to the college authorities. The site shall have to be approved by the affiliating University.

(2) The Organisers shall be required to provide adequate accommodation, essential furniture, equipment, books etc. for purpose of the college as per standard laid down by the University, at their own cost.

(3) Pending construction of the college building, classes may be held in building or near by voluntary organisation with the approval of the affiliating University.

(4) In the College there should not be any Higher Secondary Unit.

The college may, for the present, be affiliated in English, Bengali, History, Philosophy and Political science as may be recommended by the affiliating University.
