  - On behalf of the Second Party, Dr. Indra Kumar Mistri Principal, MAM will be the point of contact for further correspondence.
  - The First Party Shall not be responsible for any dispute complaints against / with the 2<sup>nd</sup> party raised by the beneficiary
  - Single point of contact from both parties.

1<sup>st</sup> Party (Union Christian Training College): Dr. Sasim Kabiraj Thakur, Principal, Union Christian training college.

2<sup>nd</sup> Party (Murshidabad Adarsha Mahavidyalaya): Dr. Indra Kumar Mistri, Principal, Murshidabad Adarsha Mahavidyalaya.

- The MoU is valid for a minimum period of Five years from the date of signature by both parties and may be renewed for any other period as shall be agreed between the parties. If either Party does not wish to continue this MoU, then such Party provides the other Party with its intention to terminate this MoU, by giving 3 (three) months' notice in writing.
- Notice: Any notice or other communication hereunder shall be in writing and shall be sent via registered post or/and E-mail, by the Parties.
- Arbitration: This MoU shall be legally binding on both Parties. If any dispute or difference of any kind whatsoever shall be settled by mediation or arbitration and arbitrator shall be appointed by both the parties in accordance with the provisions of the Arbitration and Conciliation Act, 1996 or its amendment thereof as being in force from time to time. Any dispute proceedings arising out of this MoU shall be subjected to the laws of India, and specifically within the jurisdictional court/tribunal/judicial authorities of Cuttack. The award of the Arbitrators shall be final and binding on both the parties.
